Purpose

The job holder will manage the depot stock integrity, reporting to the CI & Admin Manager, with responsibility for the delivery of cost, service, compliance, KPIs – in line with company and legal standards and requirements.

Core Accountabilities

Cost

- Ensure integrity of the depot stock in line with company policies / procedures and customer requirements
- Investigate stock losses / gains, customer credit requests, complete PI checks and take a lead in full stock counts, ensuring integrity at all times
- Work with stakeholders to ensure that the warehouse layout provides efficiencies for the warehouse teams, looking at reducing replenishments and other effected elements
- Ensure all wastage and breakage trends are investigated with a focus on reduction of stock losses

Service

- · Proactive communication with internal and external customers and suppliers / contractors
- Liaise with relevant stakeholders regarding issues affecting service to customers, both internal and external
- · Implement effective change to facilitate stakeholder requirements and depot needs
- Assist the warehouse team with identification of slow and non-moving stocks through management directed processes

Compliance

- Ensure compliance with all quality and legal documentation and standards
- Ensure customer and company requirements are observed and adherence at all times to company policies and procedures
- Accurately complete relevant audits / checks, as directed by the management, through to corrective action sign off and report of required changes
- Assist management with the collation of data for relevant meetings and reports
- · Monitor and maintain housekeeping standards in the depot. Identify, eliminate, isolate, or minimise workplace hazards
